The purpose of this test is to enable our members to test their own systems as they are in BISTECH OUCH environment.

Order entry part of the test is segmented according to required phases of routine operation. It comprises Continuous Transaction and Throttling (Maximum number of orders allowed in unit time) test sections.

Please perform the below transactions in order and make sure to check the messages incomingat every step when you carry out these transactions.

First, determine the impact expected to occur when order is sent to the system.

Whether expected impact occurred or not after order or any request is sent to the system willbe controlled by dimensional and contextual integrity and accuracy of the response which reached you with respect to the activity at the first degree. By controlling whether the activities are accurately processed or not at your main system which is the source of the activities carried out from every channel at the back in the second degree, proper blanks beloweach option will be ticked.

Inform the officers immediately if an unexpected situation occurs.

Please send the document to Borsa Istanbul officers after filling the part spared for you at the end of the test.

Legal Liability fully pertains to the member in disputes which may arise between the customers and members who do not use some of order and transaction functions in their OUCH programs which are taking part in existing transaction rules of Derivatives Market and allowed by Derivatives Market to be used with BISTECH OUCH.

For this reason, we recommend our members to inform their customers on this subject and form the proper legal basis with their customers.

#### Order Details:

- ✓ For Order Entry via OUCH Protocol, OrderBookID (SecurityID) of the instrument must be usedinstead of Symbol name. OrderBookID of the instruments that are used for Certification Test is given on the table above.
- ✓ Orders should be **Limit** priced **Day** and **Position = Open** orders unless it is noted otherwise.
- ✓ Orders should be submitted with Account **DE-1**.
- ✓ Values sent in Reference (Customer Info) field will not be checked (pass-through field). It is a mandatory field in OUCH protocol and should be sent in compliance with OUCH Specification Document.
- ✓ Clients are allowed to send Cancel Order and Enter Order (New) messages instead of sending Replace Order. Please note that cancelling an order and sending a new one will definitely cause losing the time priority of the order while it is possible to retain the time priority with

Replace Order message in certain circumstances.

# **DropCopy Connection**

Execution Report messages of Order Entry/Replace/Cancel messages that are entered via OUCH protocol will be received over FIX DropCopy connection. Clients will be provided with DropCopy connection details to be used during the Certification Test on request.

Default configuration of DropCopy connection is aimed at receiving messages of all users of the participant without any filter (FIX, TW, OUCH). It is possible to configure the DropCopy connection toreceive messages of specific users.

#### **Notes**

- ✓ In order to participate in Market Making tests, the previous test steps in the document must be completed.
- ✓ Unless otherwise stated in order entries, orders are with Limit price, Day and Position = It must be sent openly.
- ✓ A confirmation message will be sent to MassQuote messages successfully entered into the system. Additionally, if the message entered in the MassQuote Acknowledgement message contains an error, the relevant error message will be sent. The successful receipt of the message will also be confirmed by the system.
- ✓ It is recommended that the IDs to be used in the OrderToken field in the MassQuote message be produced from the same numbering series as the ClOrdID series. Therefore, this approach was adopted in the test scenario.
- ✓ The "QuoteEntryID" value, which is included in the MassQuote message and represents the quotation entered for each instrument, is given sequentially, starting from 1. These values are expected to be sent for messages containing more than one quote.
- ✓ Successful Quotation messages entered into the system are responded to. Checking whether the quotation message has been entered into the system can also be done from the Representative Screen (Trading Workstation). The Exchange Operator will carry out this control during the certification tests.
- ✓ Expected to arrive regarding all Trades made;
  - \*Mass Quote Acknowledgment or Mass Quote Rejection messages are sent via Ouch channel.
  - \*Quote Status Report, Execution Report and TCRs must also be checked by the member through the Drop Copy channel.
- ✓ In this test, it is only checked whether the necessary functions are performed. The session processes and instruments in which these functions can be used are determined by general rules and may vary.
