INFORMATION ABOUT THE CONSOLIDATED CHART:

- 1) The securities excluded from MT (Margin Trading) & SS (Short Selling) because of the Capital Markets Board (CMB) or BIST decision or the change of market segment or group change are subjected to the regulations of the temporary list until the end of the three-month period that follows the date of prohibition of margin trading and short selling.
- 2) Temporary Lists pertaining to securities excluded from margin trading and short selling in accordance with the CMB regulation about the Short-Selling and Margin Trading of Capital Market Instruments (Serial:V, Communique No:65) and Equity Market Procedure are stated in the consolidated chart above.
- 3) In accordance with the VBMS (Volatility Based Measures System), in cases when predetermined conditions are met, the first measure of "Prohibition of Short Selling and Margin Trading" is applied to the related share for a period of 15 days. If volatility continues in the share to which the first measure has been applied, the second measure of "Gross Settlement" is applied for a period of 15 days. If volatility still continues, a third measure of changing the stock's trading method from continuous trading to single price method (call auction) for 15 days is applied. Since in cases when the second and/or the third measure is applied, first measure of "Prohibition of Short Selling and Margin Trading" will be extended until the end date of the other two measures, the related share's presence in this list can be prolonged up to 45 days.

^a According to weekly bulletin of CMB dated 25/10/2013, and numbered 2013/34 duration is not stated.

- 4) Due to the VBMS, in the time frame of prohibition from the margin trading and short-selling, those shares prohibited from MT & SS cannot be subjected to new margin trading and the prevalent ones can be kept for maximum 3 months, if demanded by the parties.
