The new version of BISTECH (2.9 version) is planned to be in production as of **August 26, 2019**.

BISTECH Member Test Environment has been updated with the new version 2.9 and it is expected that you will test and check the new version before implementation.

- iii. It is expected that members and Data Vendors will perform their daily operational work, which is currently performed within the production environment, in the BISTECH Member Test Environment as well.

- vi. Access to Trading Workstation (TW) application that will be used by Equity Market, Derivatives Market and Fixed Income (FI) participants has been updated. The following features of FI market has been added to TW.
- Filter options related to “Transaction Status” is added to “Executions Screen”.
  - “Transaction/Private Transaction Report” column is added to Non-Clearing Transactions screen.

With the new version of TW application, you must log in by selecting Delete Log Files option at the first login to the system.
