**To Whom It May Concern,**

Refer to : Announcement no. 2015/88 dated 18/09/2015

As it's communicated with referred official announcement, go-live rehearsals are planned for all Equity Market participants to achieve a successful transition to BISTECH systems on 30/11/2015. The dates of these collective tests which will be carried out in production environment with the participation of all members and data vendors to let all surrounding systems be tested thoroughly before migrating to BISTECH system, are determined at the table below. These tests should be planned to cover all related systems from end to end. All scenarios which are to mimic the ones on a regular trading day in Equity Market will be tested within this scope.

In order to improve the test efficiency in the course of go-live rehearsals, BISTECH PROD environment will be accessible Saturdays and Mondays between 17/10/2015 and 07/11/2015 and it'll be accessible everyday between 09/11/2015 and 14/11/2015. The test days within the rehearsal period will be consecutive as mentioned in the table below:
