Re: Announcement of Borsa İstanbul, dated 07/08/2020 and numbered 2020/50

In the pursuit of Market-Wide Circuit Breaker System (MWCBS) establishment on 10/08/2020, it is planned to make some necessary configurations in the functioning of Equity Market, in addition to the issues stated in the Announcement numbered 2020/50.

• As published in the reference Announcement numbered 2020/50, trading in warrants, certificates, ETFs and pre-emptive right coupons (series with suffix ".V", ".C", ".F" and ".R") will be halted for 30 minutes. In this period, order cancellation, volume reduction and price worsening will be allowed while change on quotations will not be allowed.

At this stage, it is considered that it would be beneficial to allow changes on quotations (quotation entry, amendment and cancellation) in addition to the changes in orders for warrants, certificates and ETFs (series with suffix .V, .C, .F). During this period, data dissemination will be terminated from trading workstations, data vendors and ITCH in the .V, .C, .F. series. Even bid and offer prices match due to the result of the changes, uncrossing and execution of trades will not be allowed in these series. Trading and data broadcast will resume after these series will continue in their regular course again.

• In the current practice, order collection period ends randomly within 30-second time interval and uncrossing begins in the series traded via single price trading method or for those that are included in the opening or closing auctions (Uncrossing after a call auction starts randomly within 30-second time interval and order entry continues until the uncrossing phase begins). Randomized start of uncrossing which is in use in the current practice has been extended into both instrument-based circuit breaker system and market-wide circuit breaker system.

Both after instrument-based circuit breaker and MWCB system is triggered, for the series which will start trading with a call auction (currently equities, real estate investment funds, venture capital investment funds, real estate certificates) uncrossing will resume within 30-second time interval within the uncrossing phase in Equity Market.

- With the introduction of MWCBS, in order to provide operational efficiency (effective from the date specified below), it has been decided to put new session states into use. The names, descriptions and flows of these session states are included in the appendix to this Announcement.
- The Trading Workstation (TW) application, which will be used for Equity Market, Debt Securities Market and Derivatives Market connections on the BISTECH Trading Platform, has been updated by adding customized session states for MWCBS.

The updated download file with the version number "TW_bist_T_4.0.1066_SR2.11.1_r144553_ha71b371b_a145747" will be available for downloading from the sub-menus starting with "Client Application" in the BISTECH "Connect- Verda" menu from 17:00 on Friday, 21/08/2020. As of Monday, 24/08/2020 2020, TW users will only be able connect to the systems, using these new versions. For this reason, it is highly important that our members make the necessary technical and operational updates on time.

Above specified issues will be implemented (in use) as of 24th August, 2020.
