To Whom It May Concern,

With the decisions dated 14/09/2023 by the Board of Directors of Borsa İstanbul A.Ş. and 20/09/2023 by the Capital Markets Board, the following changes have been made in the criteria for determining markets for shares traded on the Equity Market:

- For BIST Stars, market capitalization has been increased from 1 billion TL to 3 billion TL, free float market capitalization has been increased from 150 million TL to 450 million TL, the domestic fund amount has been increased from 5 million TL to 15 million TL, and the liquidity value has been reduced from 1.5 to 0.5.
- For BIST Main, market capitalization has been increased from 150 million TL to 450 million TL, free float market capitalization has been increased from 60 million TL to 180 million TL, and the liquidity value has been reduced from 5 to 1.5.
- For the exceptions applied to the BIST Stars, free float market capitalization has been increased from 1.25 billion TL to 1.5 billion TL, and the liquidity value has been reduced from 1.5 to 0.5. For the two exceptions applied to the BIST Main, free float market capitalization, along with dividends, has been increased from 60 million TL to 180 million TL. For the other exception applied to the BIST Main, free float market capitalization has been increased from 120 million TL to 250 million TL, and the liquidity value has been reduced from 3 to 1.
- Regarding the margin rates determined on market basis, shares that were accepted as collateral before the date of amendment of the Directive, calculations can be made within a 1-month period using the rate valid in the market where the share was traded before the amendment.
- Regarding the Open Clearing Position / Margin Ratio, calculation can be made within a 1-month period using the rate valid in the market where the share was traded before the Directive amendment.

The amendment to the Equity Market Directive regarding the above changes will come into force as of 02/10/2023. The list showing the distribution of shares among BIST Stars, BIST Main and Sub-Market as of 02/10/2023 is included in Annex-3.
