INFORMATION REGARDING PROJECTED CHANGES TO BE MADE IN BIST-KYD INDICES METHODOLOGY

NAME OF THE CHANGE: Increasing the minimum nominal amount from TL 100 million to TL 300 million

CHANGE NUMBER: 2023-1

INDEX FAMILY: BIST-KYD Indices

DEFINITION OF THE CHANGE

BIST-KYD Indices Methodology (Methodology), for the securities included in the BIST-KYD Corporate Bond Indices and BIST-KYD Corporate Lease Certificates Indices, it is projected that the requirement for the minimum nominal amount of TL 100 million will be revised to a minimum of TL 300 million. RESULT OF THE CHANGE

According to the change, securities with a minimum nominal amount of TL 300 million can be included in the indices, and securities included in the indices with a nominal amount of less than TL 300 million will be excluded from the relevant indices as of the effective date.

REASON FOR THE CHANGE

The minimum nominal amount rule, determined as TL 100 million in December 2017, is expected to be updated to TL 300 million due to the inflation adjustment.

METHOD

Since the change affects the selection of the securities included in the indices, it is considered a material change in accordance with Article 7.2 titled “Material changes” of the Financial

Benchmarks Management Procedure. This change will be consulted to Stakeholders on the "[Index Methodologies and Changes](#)" page of the Borsa İstanbul website between the dates of 6 - 27 January 2023 in accordance with the explanations in Article 7.5 of the Financial Benchmarks Management Procedure. Those who want to present their comments can submit them on the same page by stating their preferences regarding the publication of their comments.

The comments received will be evaluated by the BIST- KYD Indices Committee and Borsa İstanbul Financial Benchmarks Committee and will be submitted to Borsa İstanbul General Management for a decision.

Borsa İstanbul Management will decide whether to make changes or not and how they will be made on 17 February 2023 at the latest, and the decision will be announced on the "Index Methodologies and Changes" page of Borsa İstanbul website on the same day.

If the decision is to make a change in the Methodology, the change to be made in the Methodology will be implemented on February 24, 2023.
