Finance Principles Information Form

To Whom It May Concern

The Advisory Board of the Participation Banks Association of Turkey, with which we cooperate in the selection of stocks to be included in the BIST Participation Indices calculated by Borsa İstanbul, made some important amendments to the “Share Certificate Issuance and Trade Standard” (Standard) and the “Guideline for Determining Companies Operating in Compliance with Participation Finance Principles” (Guideline). The current versions of the Standard and Guideline are available on the website (<https://tkbb.org.tr/danisma-kurulu>).

In line with the amendments made to the Standard and Guideline, necessary changes were made to the Participation Finance Principles Information Form in the Public Disclosure Platform (PDP) infrastructure and the updated template was launched on the Public Disclosure Platform (PDP). The template can be accessed from the “Participation Finance Principles Information Form” section in the menu on the left side of the page accessed through the PDP-Disclosure Transactions Software (BIY).

Among the companies whose shares are traded on Borsa İstanbul, all companies in the financial sector, except for brokerage houses, banks, pension companies, financial leasing and factoring companies, securities investment trusts, insurance companies, savings finance companies and asset management companies, are required to fill in the Form and publish it on PDP no later than 1 trading day after the announcement of their semi-annual and annual financial reports, taking into account the explanations in the current Standard, Guideline and Form. Disclosures should never be disclosed before the announcement of financial reports and/or during the trading session. For 3 and 9-month financial reports, there is no need to make a disclosure. Companies that have announced their 2024 6-month financial reports before the new template is put into effect are expected to make their disclosures as soon as possible using the new template.
